SUBJECT: Ordinance No. 3657, public hearing and consideration to approve

an amendment to the FY 2019-2020 Adopted Budget.

SUMMARY:

The City Council is requested to open a public hearing and receive public comment on amendments to the 2019/2020 Adopted Budget. At the conclusion of the public hearing, Council is requested to consider the approval of Ordinance No. 3657, approving the proposed budget amendment.

GENERAL DESCRIPTION:

The Fiscal Year 2019-2020 Budget was adopted by City Council on September 9, 2019 and became effective at the start of the fiscal year on October 1, 2019. On October 28, 2019 an ordinance amending the Fiscal Year 2019-2020 Budget for additional funding requirements for the replacement of the City's Enterprise Resource Planning Software was approved by the City Council. On December 9, 2019 a second amendment was approved by the City Council adding funding for grounds improvements at the Iron Horse Golf Course. On February 24, 2020 a third amendment was approved by the City Council adding funding for Fossil Creek Park improvements, a replacement ambulance, IT security, and additional funding for the Loop 820 redevelopment project. Since this time, events have occurred that necessitate a fourth amendment to the budget. The changes reflected in this amendment are summarized below.

BUDGET AMENDMENTS:

This request is to add \$380,000 in funding from unissued 2003 GO bonds to fund engineering and design work associated with a new project for the street repair of Glenview Drive East, which is approximately 2,700 linear feet of Glenview Drive from Boulevard 26 to Flory Street. The proposed construction improvements will include reconstructing the existing roadway with reinforced concrete, including the addition of sidewalks.

The impact of the amendment on the Fiscal Year 2019-2020 Capital Budget is summarized below.
