Proposition A - The issuance of \$49,875,000 of City of North Richland Hills, Texas general obligation bonds for streets, roads, sidewalks, trails and related utility and drainage improvements, the acquisition of real property necessary or incidental for such purposes and the levying of taxes sufficient to pay the principal of and interest on the bonds will be imposed.
