## LEGAL DESCRIPTION

BEING a parcel of land located in the City of North Richland Hills, Tarrant County, Texas, being a part of the Landon C. Southwesterly, 366.54 feet along a curve to the right having a central angle of 21 degrees 55 minutes 18 seconds, a radius of 958.00 feet, a tangent of 185.54 feet, and whose chord bears South 47 degrees 11 minutes 41 seconds West, 364.31 feet to a "PK" nail found for corner;

THENCE North 27 degrees 41 minutes 11 seconds West, 9.53 feet to a one—half inch iron rod with yellow cap stamped "JBI" set for corner;

THENCE Northeasterly, 362.21 feet along a curve to the left having a central angle of 21 degrees 52 minutes 48 seconds, a radius of 948.50 feet, a tangent of 183.34 feet, and whose chord bears North 47 degrees 10 minutes 26 seconds East, 360.02 feet to a one—half inch iron rod with yellow cap stamped "JBI" set for corner;

THENCE North 36 degrees 14 minutes 02 seconds East, 54.84 feet to a one—half inch iron rod with yellow cap stamped "JBI" set for corner;
