The drones flew very low, every twenty to thirty minutes, over the houses in Thornbridge. The noise and the sound of "buzzing bees" was very disruptive. We are not aware of what changes were made at the end of April to alleviate the issues. Could it have been a change in altitude, size of the drone etc?

Please ensure that those changes are implemented in the new extension.
