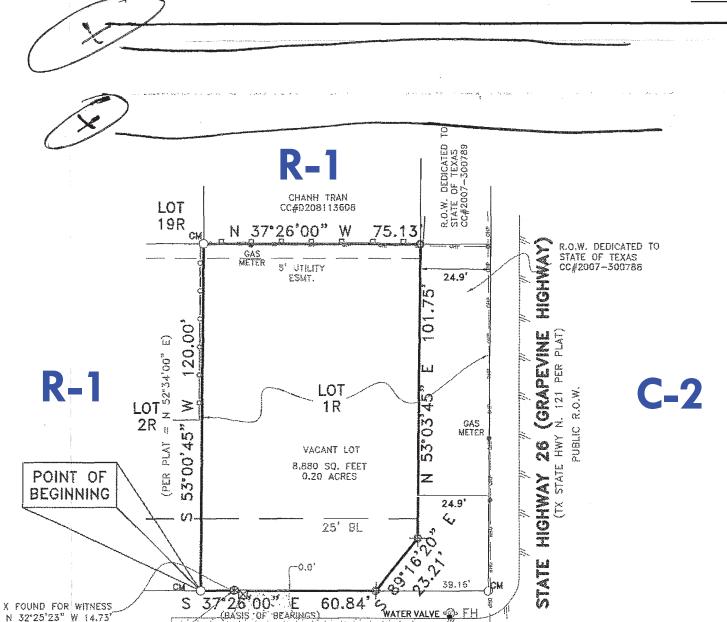

BEGINNING at a 1/2 Inch Iron rod found for corner, said corner being along the Southwest line of Jennings Drive (50 foot right-of-way), said corner being the North corner of Lot 2R of the said Addition, from which an "X" found for witness, bears North 32 degrees 25 minutes 23 seconds West, a distance of 14.73 feet for witness and from which a 60D nail found for witness, bears North 38 degrees 08 minutes 21 seconds West, a distance of 11.59

THENCE South 53 degrees 0D minutes 45 seconds West, along the Northwest line of said Lot 2R, a distance of 120.00 feet to a 1/2 inch iron rod found for corner, each corner being the North corner of Lot 19R of sald Addition and being the East corner of that tract of land conveyed to Chanh Tran, by deed recorded in County Clerk's File Number D208113608, Official Public Records of Tarrant County, Texas;

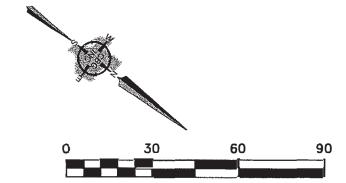
THENCE North 37 degrees 26 minutes 00 seconds West, along the Northeast line of said Tran tract, a distance of 75.13 feet to a point for corner, said corner being along the Southeast line of State Highway No. 26 (public right-of-woy);

THENCE North 53 degrees 03 minutes 45 seconds East, along the Southeast line of said State Highway No. 26, a distance of 101.75 feet to a point for corner;

THENCE South 89 degrees 16 minutes 20 seconds East, along the South line of the Intersection of said Jennings Drive and said TX. State Highway No. 121, a distance of 23.21 feet to a point for corner, from which a 1/2 inch iron rod found, bears North 37 degrees 26 minutes 00 seconds West, a distance of 39.16 feet for witness;

THENCE South 37 degrees 26 minutes 00 seconds East, along the Southwest line of said Jennings Drive, a distance of 50.84 feet to the POINT OF BEGINNING and containing 8,880 square feet or 0.20 acres of land.
