Receiving Jurisdiction/Agency confirms and acknowledges that it has been provided a copy of the Addendum and has been provided an opportunity to review and request modifications to the Addendum, including review by its legal counsel as needed. The Receiving/Jurisdiction Agency intends to execute the Addendum upon final approval by its governing body or other officer who has authority to execute agreements on its behalf.
