**SUBJECT: BID NO. 2022-064 - ANNUAL CONTRACT FOR COLD MILLING MACHINE WITH OPERATOR AND HELPER - COUNTYWIDE - TEXOP CONSTRUCTION, LP - PER UNIT PRICE AND DISCOUNT FROM LIST PRICE**

**COMMISSIONERS COURT ACTION REQUESTED**

It is requested that the Commissioners Court award Bid No. 2022-064, Annual Contract for Cold Milling Machine with Operator and Helper, Countywide, to TexOp Construction, LP at the per unit price and discount from list price.

**BACKGROUND**

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Arlington Black Chamber of Commerce, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. One hundred ninety-four (194) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. No vendors attended the pre-bid conference held on February 2, 2022. One (1) bid and one (1) no-bid were received.

The bid received from TexOp Construction, LP meets all specifications and is acceptable to all four (4) Maintenance Precincts and Purchasing.

The term of contract is twelve (12) months, effective April 5, 2022, with two (2) options for renewal periods of twelve (12) months each.

Therefore, it is the joint recommendation of all four (4) Maintenance Precincts and Purchasing that Bid No. 2022-009, Annual Contract for Cold Milling Machine with Operator and Helper, be awarded to TexOp Construction, LP, at the per unit price and discount from list price.

**FISCAL IMPACT**

There were no expenses for last year. Orders are placed on an as-needed basis.
