B.1 ZBA24-0013 PUBLIC HEARING AND CONSIDERATION OF A REQUEST FROM DARYL AND KRISTEN SPANN FOR A VARIANCE FROM SECTION 118-674 (ROOF PITCH RATIO) OF THE NORTH RICHLAND HILLS ZONING ORDINANCE AT 4604 VANCE ROAD, BEING 0.279 ACRES DESCRIBED AS LOT 2, BLOCK 16, NORTH RICHLAND HILLS ADDITION, SECOND FILING.
