

RESOLUTION NO. 2024-014

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NORTH RICHLAND HILLS, TEXAS, AUTHORIZING SUBMISSION OF THE APPLICATION AND ACCEPTANCE OF ALLOCATED FUNDS IF AWARDED FOR THE Texas Parks and Wildlife Department (TPWD) Recreational Trails Grant for City Point Trail, Grant #REC-2024-Cityof NRH-00050 effective October 1, 2024.

WHEREAS, The City of North Richland Hills, Texas possesses legal authority to apply and make appointments for the conduct of business relative to the Texas Parks and Wildlife Department (TPWD) Recreational Trails Grant for City Point Trail, Grant #REC-2024-CityofNRH-00050; and

WHEREAS, The City of North Richland Hills, Texas finds it in the best interest of the citizens of North Richland Hills that we request the funds available under this Program to support in the construction of a 10' wide multi-use trail in the Oncor easement west of City Point development from Glenview Drive to an existing 6' wide residential pedestrian trail system adjacent to City Point Phase 2 along Blvd 26. This project will serve to connect residents in the development along the west side of City Point with a 10' wide multi-use trail from Glenview Drive northward into the existing NRH residential trail system starting at the signalized intersection of City Point Drive and Blvd 26.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH RICHLAND HILLS, TEXAS, THAT:

SECTION 1. The City Council of the City of North Richland Hills hereby finds that the recitals set forth above are true and correct and are incorporated into this Resolution as if written herein.

SECTION 2. The City Council of the City of North Richland Hills hereby authorizes and approves the submission of the application and acceptance if awarded for the Texas Parks and Wildlife Department Recreational Trails Grant for City Point Trail, Grant #REC-2024-CityofNRH-00050.

SECTION 3. The City Council of North Richland Hills agrees to provide 20% of the total project for the required match funding.

SECTION 4. The City Council of the City of North Richland Hills designates Adrien Pekurney, Director of Parks and Recreation as the grantee's authorized official, with the power to apply for, accept, reject, alter or terminate the funding request on behalf of the applicant agency.

SECTION 5. The City Council of the City of North Richland Hills agrees that the loss or misuse of TPWD funds or failure to comply with all TPWD award requirements may result in suspension or termination of award funds, the repayment of award funds, and/or other remedies available by law.

SECTION 6. That this Resolution shall take effect and be in full force and effect from and after the date of its adoption, and it is so resolved; and all Resolutions of the City Council of the City in conflict herewith are hereby amended or repealed to the extent of such conflict.
