AMENDMENT TO CITY OF NORTH RICHLAND HILLS AGREEMENT FOR ENGINEERING SERVICES

THE STATE OF TEXAS §

THE COUNTY OF TARRANT §

WHEREAS, the City of North Richland Hills ("City") and KIMLEY-HORN AND ASSOCIATES, INC., ("Engineer") collectively referred to as the "parties," made and entered into an Agreement for Engineering Services effective on June 25, 2024 ("Agreement"); and

WHEREAS, the Agreement involves professional engineering services in connection with the NRH2O KIDDIE AREA RENOVATION PROJECT; and

WHEREAS, the Agreement provides for a maximum expenditure amount not to exceed \$155,000.00; and

WHEREAS, City and Engineer have determined that additional expenditures are necessary for construction documents, bidding, and construction administration that were not a part of the original estimated values used to develop the previously approved amount of \$155,000.00; and

WHEREAS, the parties now wish to amend the Agreement to increase the authorized amount to \$415,000.00 to provide services for the project;

NOW THEREFORE, City and Contractor, acting herein by and through their duly authorized representatives, enter into the following agreement:

1. Section V of the Agreement is amended to read as follows:

Additional Engineering Services are defined in Exhibit D: "Additional Engineering Services," attached hereto and made part of this Agreement. The CITY will pay ENGINEER for the following: "Tasks 1B (Construction Documents), 2B (Bidding Phase and Contract Award), and 3B (Construction Contract Administration)." No other Additional Engineering Services are authorized unless authorization for specified additional services are provided to ENGINEER by CITY in writing and approved by CITY.

2. Paragraph B of section VII of the Agreement is amended to read as follows:

Total payments including without limitation reimbursable expenses, to ENGINEER by CITY for the services stated in Section IV and V above shall not exceed FOUR HUNDRED FIFTEEN THOUSAND DOLLARS (\$415,000.00). For clarity, this includes \$155,000.00 for Scope of Engineer's Services (Section IV); and \$260,000 for Additional Engineering Services (Section V).

3. All other provisions of the Agreement that are not expressly amended herein shall remain in full force and effect.
