2. All other provisions of the Agreement that are not expressly amended herein shall remain in full force and effect.





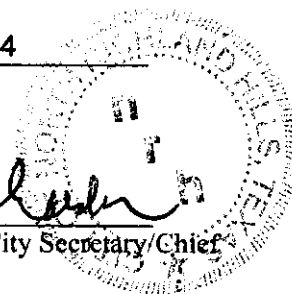
