

RESOLUTION NO. 2016-024
A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NORTH
RICHLAND HILLS; APPOINTING MEMBERS TO VARIOUS
BOARDS, COMMISSIONS, AND COMMITTEES; ESTABLISHING
TERMS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, City Council appoints members of the public to serve on various boards, commissions, and committees; and

WHEREAS, appointed members serve a two-year term, unless appointed to fulfill an unexpired term; and

WHEREAS, annual appointments coincide with City Council terms with Places 1, 3, 5, and 7 being appointed in odd-numbered years and Places 2, 4, 6, and Mayoral appointments in even-numbered years; and

WHEREAS, each member serves until their successor has been duly appointed and qualified; and

WHEREAS, Council made their initial appointments on July 25, 2016; and

WHEREAS, Council members in Places 2, 4, 6 and the Mayor have submitted their remaining nominations for consideration by the City Council.
