SUBJECT: Approve Resolution No. 2023-059, appointing members to various

boards, commissions and committees.

PRESENTER: Alicia Richardson, City Secretary / Chief Governance Officer

SUMMARY:

Each year, the City Council appoints members of the public to serve on various boards, commissions, and committees (the "Boards"). Appointed members serve a two-year term, unless appointed to fulfill an unexpired term. These annual appointments coincide with City Council terms—Places 1, 3, 5, and 7 and are appointed in odd-numbered years and Places 2, 4, 6, and Mayoral appointments in even-numbered years. Each member serves until his or her successor has been duly appointed and qualified.

GENERAL DESCRIPTION:

In preparation for the annual appointments, staff provides City Council with resource material to assist with the appointment process. In preparation for the 2023 appointments, City Council was provided a copy of the current membership for each Board, attendance report, and current applications on file with the city.

In accordance with city charter, state law and city ordinances, council members nominate a member of the public to serve in the corresponding place on the Board. The submitted nominations are subject to majority approval of City Council.

There are a number of Boards with unique membership requirements. These Boards include the Capital Improvement Advisory Committee, Civil Service Commission, Construction Code Appeals Board, Gas Board of Appeals, Naming Board, Substandard Building Board and Youth Advisory Committee.

Mayor Trevino and Council members Rodriguez, Compton, Vaughn and Deupree have submitted the below nominees for consideration by City Council. The listing also includes recommendations by city staff for the Animal Adoption and Rescue Center Advisory Committee, Construction Code Appeals Board and Economic Development Advisory Committee.



ANIMAL ADOPTION AND RESCUE CENTER ADVISORY COMMITTEE

Ordinance No. 1616 establishes the membership requirements as Licensed Veterinarian (Place 1), City Official (Place 2), Animal Control Shelter employee (Place 3), and Animal Welfare Organization representative (Place 4). Places 1 and 3 expire in odd-numbered years and Places 2 and 4 expire in even-numbered years.

City staff recommends the reappointment of Dr. Johnson, and Ms. Martinez with terms expiring June 30, 2025. The city is in receipt of Mr. Sabatucci's resignation from Place 4. Staff recommends the appointment of Edward Cruz to Place 4 to fulfill the remainder of the term. Staff seeks direction from City Council regarding appointment to Place 2, which is currently held by Council member Compton.

CONSTRUCTION CODE APPEALS BOARD

Section 98-42 of the North Richland Hills Code of Ordinances states that appointments are recommended by city staff and appointed by City Council. The membership shall include one (1) registered master electrician, one (1) state-licensed master plumber, one (1) master mechanical contractor, and one (1) registered design professional with architectural or civil/structural engineering experience and licensed by the state of Texas. The remaining members shall be knowledgeable of construction methods and materials with at least 10 years of building construction experience.

The following are staff recommendations to reappoint members whose terms expire this year.

CIVIL SERVICE COMMISSION

City Charter, Article XVII establishes the membership of the Civil Service Commission. Members are appointed by the Mayor and confirmed by a two-thirds (2/3) vote of the City Council. Positions 2 and 4 shall be appointed from a list or lists of nominees provided to the Mayor by employee associations. The terms are as follows: Positions 1 and 2, one-year term; Positions 3 and 4; two-year term; and Position 5, three-year term. The position of ex-officio is a two-year term.

ECONOMIC DEVELOPMENT ADVISORY COMMITTEE

In 1998, City Council created the Economic Development Advisory Committee to provide business and employee input on policies, plans and strategies that promote quality of life and economic health in the city. Members consist of 10 leaders serving staggered two-year terms representing different spectrums of business.

Staff recommends the reappointment of five existing board members and one new appointment to fulfill the vacancy created by Mike Vasquez's resignation from the committee.

NAMING BOARD

The Naming Board was established by Ordinance No. 2517, for the purpose of submitting recommendations to the City Council for the naming of city facilities to include parks, buildings, streets and other publicly owned facilities. The membership of the board consists of three council members for a term of one year. The ordinance provides that the appointments are the recommendation of the Mayor, subject to approval of the City Council.

Currently, there is one vacancy and Council members Rodriguez and Wright Oujesky serve on the board. Mayor Trevino recommends the following members be appointed to serve on the Naming Board for a term of one year.

PARK AND RECREATION FACILITIES DEVELOPMENT CORPORATION

The Articles of Incorporation and Bylaws establish the membership for the Board of Directors, which includes the number, term, and classification. Places 1-4 shall be a member of the City Council and Places 5-7 are citizens who are not employees of the city or a member of City Council. Historically, City Council has appointed Park and Recreation Board members to serve in Places 5-7.

The Bylaws provide for a chairman of the Board, which shall be the mayor or mayor prothem of the city. The chairman will preside at board meetings.

The Articles of Incorporation identify Places 1, 5, and 7 as being appointed in evennumbered years and Places 2, 3, 4 and 6 being appointed in odd-numbered years with a term of two years.
