SUBJECT: Award bid 18-006 for annual NRH₂O food service products to

multiple vendors in an amount not to exceed \$175,000.

SUMMARY:

The City Council is being asked to award a bid for NRH₂O Food Service Products for the 2018 season to multiple vendors. The annual contract will cover a six month period (April 08 through September 30, 2018).

GENERAL DESCRIPTION:

Bidders were requested to submit prices on a list of specific food items as well as specific brands that were high volume sellers over the past year. Evaluation factors included brand of food item offered, price, quality, and customer service response. Although the contract will be awarded by section as indicated in the bid specification, the total will exceed \$50,000. Therefore, staff is recommending this contract be approved by the City Council.

This competitive bid was advertised to the public through the Fort Worth Star Telegram and via the North Richland Hills website. Five bids were received from the following firms:
