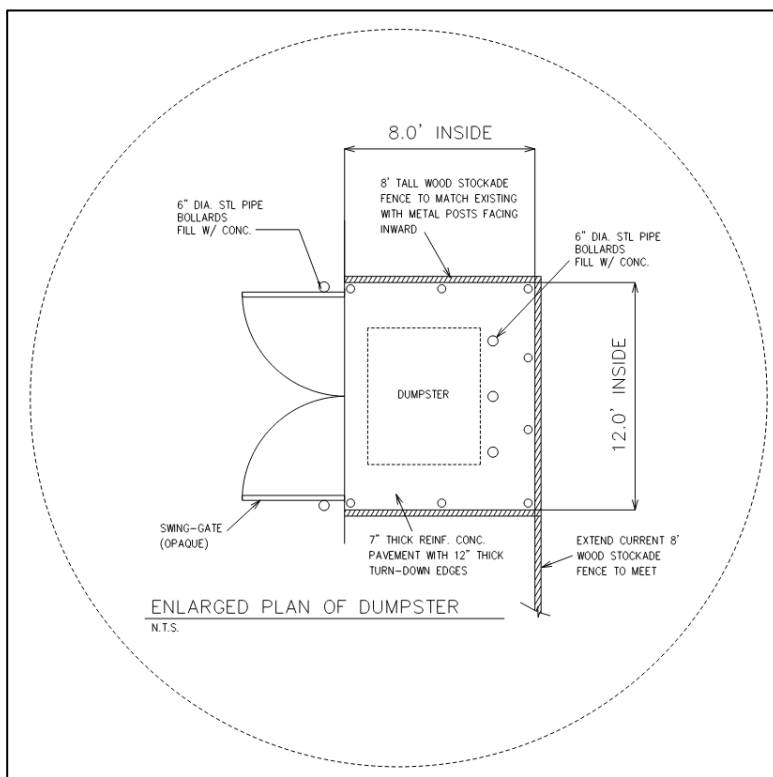
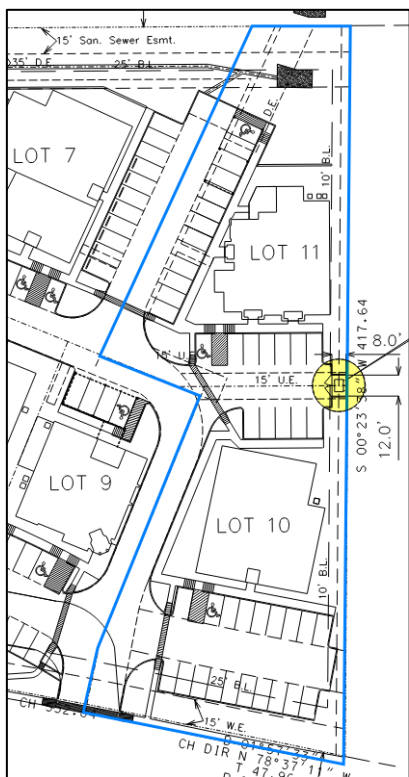
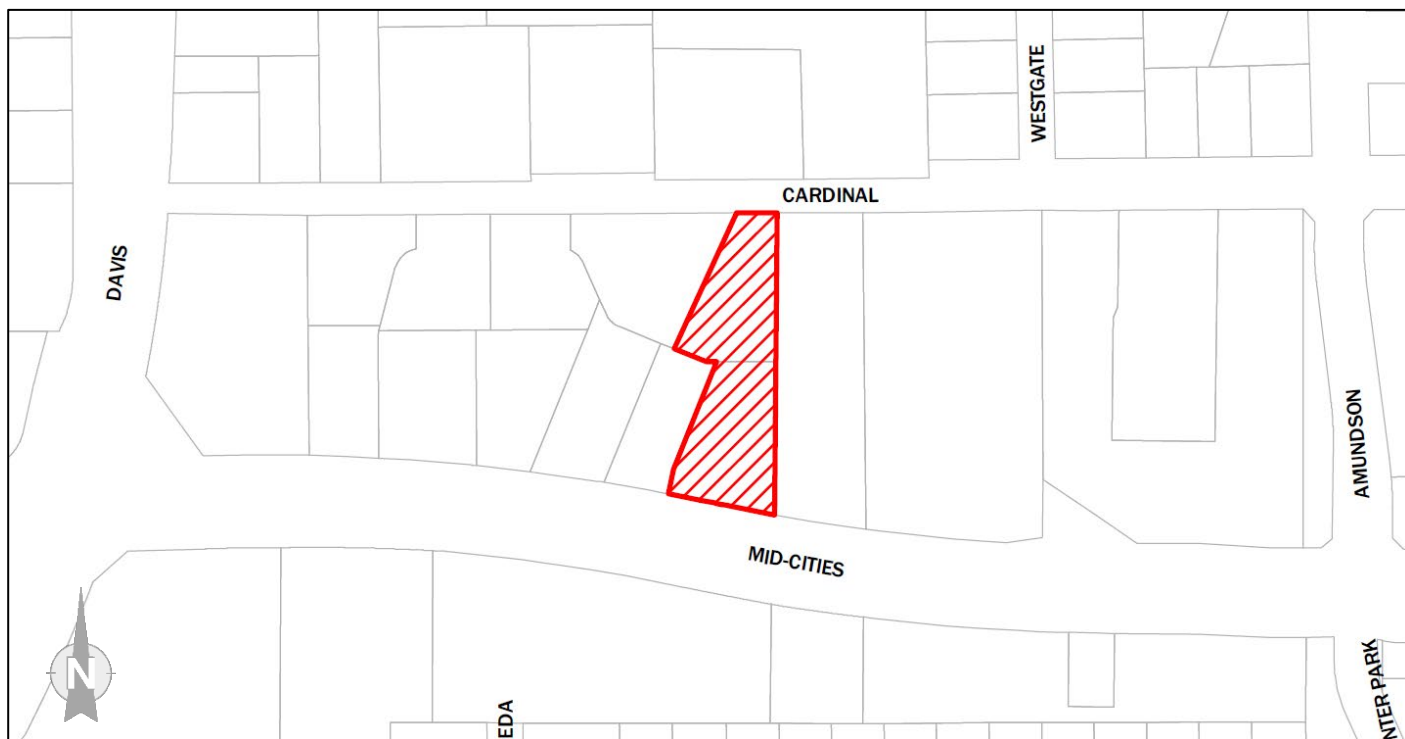

You are receiving this notice because you are a property owner of record within 200 feet of the property requesting a variance from the zoning ordinance as shown on the attached map.

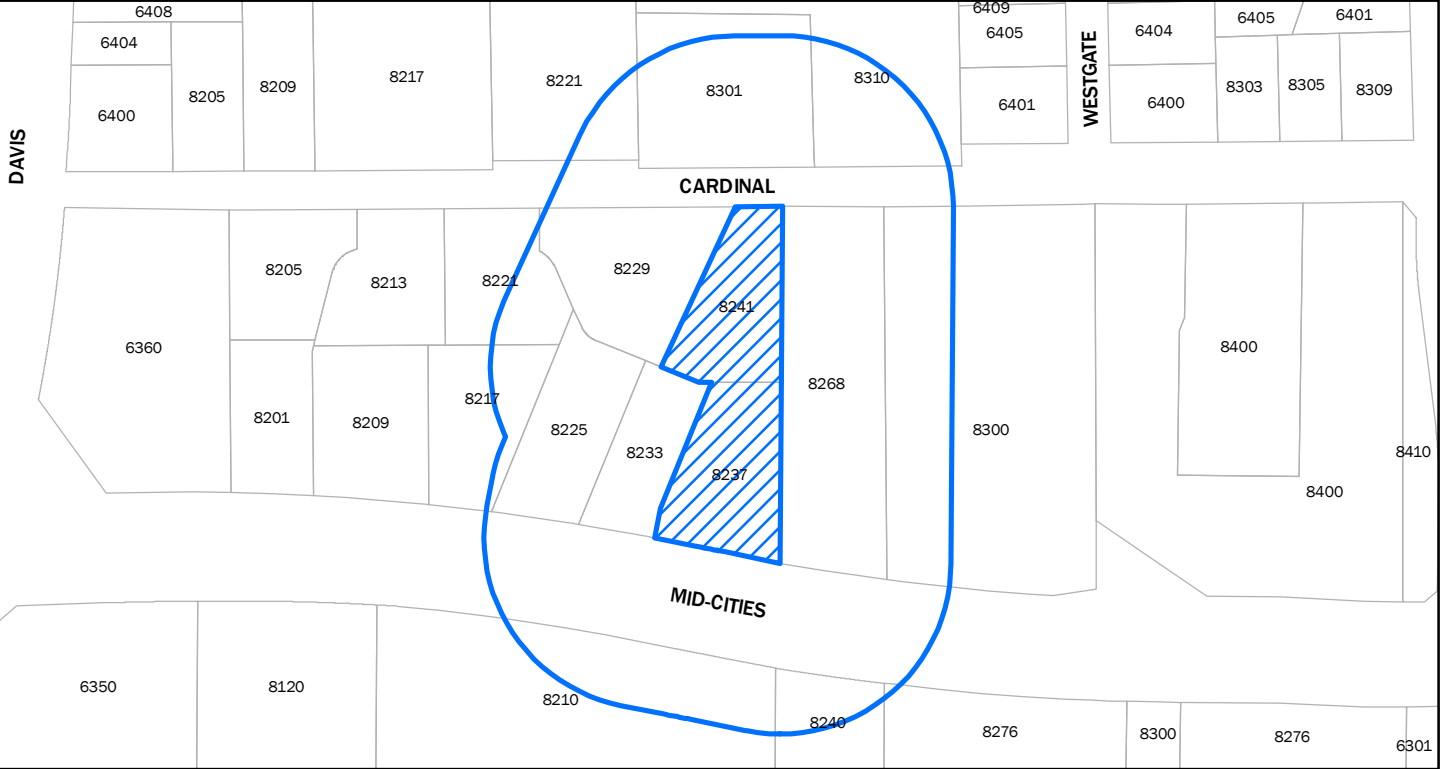
<b>APPLICANT</b>	Hamilton Duffy PC and Bohannon Dentistry

<b>REQUEST</b>	Public hearing and consideration of a request from Hamilton Duffy PC for a variance from Section 118-874 (screening of outdoor refuse containers) of the North Richland Hills zoning ordinance at 8237 and 8241 Mid-Cities Boulevard, being 1.01 acres described as Lots 10 and 11, Block 1, Pavillion Park Addition.
<b>DESCRIPTION</b>	Proposed variance from the required screening for outdoor refuse containers (dumpsters) to allow screening to be a wood fence rather than the required masonry fence. The container is shared between two properties.
