The agencies designated as Constituent Organizations to this Local Administrative Agreement Between the Constituent Agencies of the Texas Anti-Gang Center – North Texas ("Agreement"), are:

- Dallas County District Attorney's Office
- Dallas Police Department

- Fort Worth Police Department
- U.S. Department of Homeland Security, U.S. Immigration and Customs Enforcement, Homeland Security Investigations, Dallas Field Office
- Irving Police Department
- North Richland Hills Police Department
- Tarrant County Criminal District Attorney's Office
- Texas Department of Public Safety, Region 1

For convenience, the Constituent Organizations may be referred to collectively as "parties" and individually as a "party," and the Texas Anti-Gang Center – North Texas as "TAG Center."

WHEREAS, the parties hereto in 2016 entered into an Agreement to establish the TAG Center ("Agreement"); and

WHEREAS, ultimate governance of the TAG Center is vested in an Executive Board ("Board") comprised of the principal of each of the parties, each having an equal vote on all matters before the Board; and

WHEREAS, the Initial Term of the Agreement expired on February 17, 2019 ("Initial Term"); and

WHEREAS, the Board has authority to take any action with respect to the TAG Center that is not inconsistent with the Agreement and applicable law; and

WHEREAS, the parties wish to renew and amend the Agreement to continue the TAG Center with an effective date beginning at the end of the initial term of the Agreement;

NOW THEREFORE, for and in consideration of the mutual promises and covenants set forth in this Agreement, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1.

The parties agree to be bound by the terms and conditions of the Agreement which are hereby restated, except as otherwise modified herein.

2.

This Amendment and First Renewal shall have an effective date beginning at the end of the Initial Term of the Agreement.

3.

The Agreement is hereby amended by deleting Section XV, "Duration of the TAG Center," of the Agreement in its entirety and replacing it with the following:

"Section XV. Duration of the TAG Center." The TAG Center shall continue in effect until September 30, 2023, unless extended by written agreement of the Constituent Organizations through a separate renewal.

Except as herein amended, the terms and conditions of the Agreement shall continue in full force and effect.

THIS AMENDMENT AND FIRST RENEWAL SHALL TAKE EFFECT UPON EXECUTION OF EACH PARTY.
