A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NORTH RICHLAND HILLS, TEXAS, AUTHORIZING EXECUTION OF A REGIONAL ASSET TRANSFER ADDENDUM WITH THE CITY OF DALLAS FOR THE PURCHASE OF TWO (2) CHEVROLET TAHOES BY THE CITY OF NORTH RICHLAND HILLS USING NORTH TEXAS ANTI-GANG CENTER FUNDS

WHEREAS, The City of North Richland Hills, Texas possesses legal authority to enter into a Regional Asset Transfer Addendum ("Addendum") with the City of Dallas ("Dallas") to facilitate the transfer of ownership and responsibility for two (2) Chevrolet Tahoes ("Asset(s)") purchased with allocated funds awarded under the FY2023 North Texas Anti-Gang Center Project Grant #2848908; and

WHEREAS, Both parties acknowledge that all rights, title, interest, ownership, and responsibility for the Asset(s) shall vest with Dallas upon completion of transfer of the Asset(s) and execution of this Addendum; and,

WHEREAS, The City Council of North Richland Hills finds it in the best interest of the citizens of North Richland Hills that we request the attached Addendum be executed; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH RICHLAND HILLS, TEXAS, THAT:

- **SECTION 1.** The City Council hereby finds that the recitals set forth above are true and correct and are incorporated into this Resolution as if written herein.
- **SECTION 2.** The City Council of the City of North Richland Hills hereby authorizes and approves the Addendum to facilitate the transfer of ownership and responsibility for Asset(s) purchased with allocated funds awarded under the FY2023 North Texas Anti-Gang Center Project Grant #2848908.
- **SECTION 3.** The City Council of the City of North Richland Hills hereby authorizes and approves the City Manager to execute the Regional Asset Transfer Addendum with Dallas.
- **SECTION 4.** This Resolution shall take effect and be in full force and effect from and after the date of its adoption, and it is so resolved; and all Resolutions of the City Council of the City of North Richland Hills in conflict

herewith are hereby amended or repealed to the extent of such conflict.
