SUBJECT: Consider Resolution No. 2017-017, approving and authorizing

publication of Notice of Intention to Issue Certificates of Obligation

## **SUMMARY:**

The Fiscal Year 2016/2017 Budget includes certain projects to be financed with Certificates of Obligation (CO's). The proposed sale will occur on May 8, 2017 and result in project proceeds of approximately \$7,815,000. As part of the legal requirements for the planned issuance of CO's, the City Council must authorize the City Secretary to publish, in a newspaper of general circulation, the notice of intent of the City to issue Certificates of Obligation in an amount not to exceed \$7,960,000.

## **GENERAL DESCRIPTION:**

The estimated funds for the 2017 CO Projects and associated cost estimates are as follows:

The notice of intent to issue CO's must be published once a week for two consecutive weeks. The first publication date shall be at least thirty-one (31) days prior to the date stated therein for the passage of the ordinance authorizing the issuance of the CO's. The notice of intention is attached and labeled Exhibit A.
