A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NORTH RICHLAND HILLS RECOMMENDING AWARD OF A CONSTRUCTION CONTRACT BY TARRANT COUNTY TO MCCLENDON CONSTRUCTION COMPANY FOR THE 44<sup>th</sup> ANNUAL COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM PROJECT IDENTIFIED AS SCHILLER DRIVE STREET IMPROVEMENT PROJECT WITHIN THE CITY OF NORTH RICHLAND HILLS AND PROVIDING AN EFFECTIVE DATE.

- WHEREAS, The Schiller Drive Street Improvement Project was bid by Tarrant County as a Community Development Block Grant (CDBG) Project on December 13, 2018; and,
- WHEREAS, CDBG funds available for the construction of Schiller Drive Street Improvement Project total \$253,410.00; and,
- WHEREAS, The City of North Richland Hills has allocated an additional \$35,000.00 in funds to compliment the City's CDBG funding allocation for the construction of the Schiller Drive Street Improvement Project; and,
- **WHEREAS,** Tarrant County's consultant and City staff have recommended award of the Project's bid to McClendon Construction Company; and,
- **WHEREAS,** Tarrant County desires a recommendation by the City Council of the City of North Richland Hills to award the contract;

# NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH RICHLAND HILLS, TEXAS:

- **SECTION 1.** That the City of North Richland Hills hereby recommends that Tarrant County award the contract for the Schiller Drive Street Improvement Project (CDBG) to McClendon Construction Company in the amount of \$254,224.00, which includes City funding of \$814.00.
- **SECTION 2.** That this Resolution shall take effect and be in full force and effect from and after the date of its adoption, and it is so resolved; and all resolutions of the City Council of the City in conflict herewith are hereby amended or repealed to the extent of such conflict.
