## **RESOLUTION NO. 2019-022**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NORTH RICHLAND HILLS, TEXAS, AUTHORIZING THE FLEET SERVICES MANAGER, FLEET SERVICES SUPERINTENDENT, AND FLEET SERVICES ADMINISTRATIVE SECRETARY TO SIGN ALL DOCUMENTS RELATING TO THE CITY OF NORTH RICHLAND HILLS VEHICLE REGISTRATIONS, VEHICLE TITLES, AND VEHICLE LICENSE PLATES AS THE REPRESENTATIVE FOR THE CITY OF NORTH RICHLAND HILLS AND TO REQUEST REGISTRATION OF NORTH RICHLAND HILLS VEHICLES THAT ARE EXEMPT FROM THE INSCRIPTION REQUIREMENT UNDER TEXAS TRANSPORTATION CODE §721.005; AND PROVIDING AN EFFECTIVE DATE.

- WHEREAS, the City of North Richland Hills, Texas (the City), desires to officially designate a specific position with the duties of signing all documents relating to the City's vehicle registrations, vehicle titles and vehicle license plates as the City's representative; and
- WHEREAS, there are certain vehicles owned by the City of North Richland Hills which are exempt under the Texas Transportation Code §721.005 from the requirement that city vehicles be clearly marked as such when used in the performance of official duties; and
- **WHEREAS**, the City Council requests that the Texas Department of Transportation issue regular license plates, fee exempt, for use by the City of North Richland Hills upon proper application by such designated person; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTH RICHLAND HILLS, TEXAS, THAT:

- **SECTION 1.** The City Council hereby finds that the recitals set forth above are true and correct and are incorporated into this Resolution as if written herein.
- SECTION 2. That the Fleet Services Manager, Fleet Services Superintendent, and Fleet Services Administrative Secretary are hereby authorized to sign all documents relating to the City of North Richland Hills vehicle registrations, vehicle titles and vehicle license plates as the representative, and to request registration of North Richland Hills vehicles that are exempt from the inscription requirement under Texas Transportation Code §721.005.
- **SECTION 3.** That this Resolution shall take effect and be in full force and effect from and after the date of its adoption, and it is so resolved; and all Resolutions of the City Council of the City in conflict herewith are hereby amended or repealed to the extent of such conflict.
