## **BACKGROUND:**

Notice of the County's intent to bid was advertised in local newspapers, as required by State statute, and posted on the Internet, the Fort Worth Hispanic Chamber of Commerce, the Fort Worth Metropolitan Black Chamber of Commerce, and the Tarrant County Asian American Chamber of Commerce. Two hundred forty-seven (247) vendors were contacted and requested to participate in this bid process. All documents pertaining to this bid were posted on the Tarrant County website and were downloaded by interested bidders. A pre-bid conference held on October 10, 2018 was attended by twelve (12) vendors as well as representatives from Transportation Services and Purchasing. Sixteen (16) bids were received and one (1) no-bid was received.

Bids were evaluated by Transportation Services and Purchasing representatives. Award recommendations are to the low bids meeting specifications. The bid received from Bossier Dodge was deemed non-responsive for failure to sign Addendum 1 as required. The bid received from Red McCombs Ford was deemed non-responsive for failure to sign Addendum 1 as required. The bid received from Randall Reed's Prestige Ford for Item 11B did not meet specifications because delivery time was not included as required.
