THAT, Rachel Leigh Jackson and Jerry Robert Jackson, do hereby adopt this plat designating the hereinabove described real property as LOT 7R1, BLOCK 3, MORGAN MEADOWS ADDITION, an addition to the City of North Richland Hills, Tarrant County, Texas, and do/does hereby dedicate to the public uses the streets, alleys, right-of-ways, and any other public areas shown on this plat. The easements shown thereon are hereby reserved for the purposes indicated. The utility and fire lane easements shall be open to the public, fire and police units, garbage and rubbish collection agencies, and all public and private utilities for each particular use. The maintenance of paving on the utility and fire lane easements is the responsibility of the property owner. No buildings, fences, trees, shrubs, or other mprovements or growths shall be constructed, reconstructed or placed upon, over or across improvements or growths shall be constructed, reconstructed or placed upon, over or across the easements as shown. Additional easement area is also conveyed for installation and maintenance of manholes, cleanouts, fire hydrants, water services and wastewater services from the main to the curb or pavement line, and description of such additional easements herein granted shall be determined by their location as installed.
