The purpose of the public hearing is to consider an amendment to the current Impact Fee Study to correct the wastewater collection rate per service unit equivalent. The current impact fee per service unit remains unchanged at \$1,851 for water and \$1,210 for wastewater. Any member of the public has the right to appear at the hearing and present evidence for or against proposed impact fees.

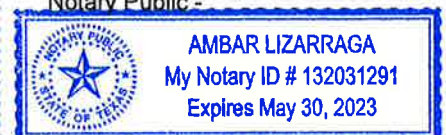
