Notice is hereby given that a meeting of the City of North Richland Hills Substandard Building Board will be held at 6:00 p.m. on Tuesday, November 9, 2021, at the City of North Richland Hills City Hall, Council Workroom – 3<sup>rd</sup> Floor, 4301 City Point Drive, North Richland Hills Texas 76180. A public hearing will be held to consider action regarding the following substandard residential building, accessory building, and accumulation in accordance with the city's substandard building regulations, North Richland Hills Code of Ordinances, Chapter 98.

Violations of city standards present at the buildings are as follows:

- 1. Exterior of structures have accumulation of trash and debris.
- 2. Both exterior and interior of both structures must be brought to minimum code requirements, or structures must be demolished.

Notifications of these violations were sent on May 4, 2021, September 24, 2021, and October 13, 2021.

The board will determine whether the buildings and property maintenance comply with the standards set out in the ordinances and consider whether to uphold the Building Official and the Director of Neighborhood Services order to repair or demolish structures and remove all debris. In either case, if the ordered action is not taken within a reasonable time specified by the Board, the City may vacate, secure, remove, or demolish the buildings, remove the accumulation or relocate the occupants of the building and levy the cost thereof as a special assessment against the property. The Board may assess civil penalties against the property owner for non-compliance.

The owner and/or all parties having interest in such property will be required to submit proof of the scope of any work that may be required to comply with the ordinance and the time it will take to reasonably perform the work. D221309728 Page 2 of 2
